Notes:

PWs operating at coastal sites, or from superyachts, should be equipped as per this checklist. However, PWs accompanied by a safety boat equipped as per the powerboat training vessel checklist are required only to carry those items in the PW checklist which do not feature on the powerboat training checklist.

TCPW1 Killcords

Fully functional killcords that must be fitted and used at all times when underway. Killcords will usually be attached to the rider's buoyancy aid.

TCPW2 Impact buoyancy aids

Consideration should be given to the use of impact vest buoyancy aids, to provide both personal buoyancy and protection of the torso. **From April 2022:** Impact buoyancy aids, which provide both protection to the torso and personal buoyancy, should be worn.
